South Yorkshire Safety Cameras Have no control over the setting of the Variable Speed Limits, where they are set or their duration. This is the responsibility of the Highways Agency who set the variable speed limits according to the ongoing current situation on the motorway, such as obstructions, broken down vehicles or accidents for example. South Yorkshire Safety cameras merely process any Offences detected. Because of the unpredictable nature of incidents, there is no consistent data for any given period or day on which to formulate an average.
